4. Quotations will be opened in presence of the buyer or their authorized representatives whosoever will be present on quotation opening date 07/01/2022 at 3.30 PM at BECIL BHAWAN at C-56/A-17, Sector-62, Noida 201307.
5. Quotations received without quotation fee and Earnest Money Deposit will be out rightly rejected and no further communication in this regard shall be entertained.
6. If there is any difference between the quoted amount in figures and words, the amount mentioned in “words” will be considered.
7. The buyer should be registered and have GST Number. The buyer which does not have GST Number, their quotation will be rejected.
8. The buyer should have PAN Number.
9. Email and fax based quotations will not be accepted.
