Tender Title: Short Notice for Inviting Tender (Invited through e-Tendering mode only) For selection of a professional agency for Event Management for 'Varanasi Film Festival' to be held from 27th to 29th December 2021 at Rudraksh International Cooperation and Convention Centre, Varanasi

1. This notification is in continuation of the tender number BECIL/IPRD-UP/VFF/2021/Tender/01 published by BECIL for Selection of a professional agency for Event Management for 'Varanasi Film Festival' to be held from 27th to 29th December 2021 at Rudraksh International Cooperation and Convention Centre, Varanasi.
2. The following amendments in tender No. BECIL/IPRD-UP/VFF/2021/Tender/01 are brought to the notice of all concerned.

a) Addition of the new General Conditions under Terms of Reference Annexure-I.

- i. Film Festival will be organized at Rudraksh International Cooperation and Convention Centre and Musical Evening will be organized at Open Stadium (Dr. Sampurnanand Sports Stadium).
- ii. Before submission of the proposals, prospective agencies are required to carry out a detailed recce of the venues.
- iii. It shall be responsibility of the successful agency to obtained requisite permission for DCP, ACP Traffic, Municipal Corporation and other statutory bodies for permission for organization of the event and Installation Publicity materials during the event.

- iv. It would be the responsibility of the selected bidder to arrange for sufficient number of dustbins, fire extinguishers, sand buckets, chair, tables, canopies, public address system and sound system for musical evening fool proof security with required gadgets, cleanliness, etc.
- v. All electrical installations must be in accordance with the provision of the Regulations for Licensing and Controlling places of Public Amusement (other than Cinemas) and the performances of Public Amusement, 1980.
- vi. Removal of garbage from the site and its disposal to the nearest municipal corporation dustbin is the responsibility of selected bidder.
- vii. The selected bidder would also be responsible for constructing a stage and green room at the Open Stadium (venue for Musical Evening). All the expenditure on ambiance creation, JBL/ Bose sound system (stand mikes, cordless mikes, Lapel Mike, etc as per requirement of performing artists) & light arrangements on truss for the musical evening program would be the responsibility of the selected bidder. Permissions required IPRS, PPL etc. for musical evening has to be taken by the event manager.
- viii. Security arrangements during the musical evening including: (a) Sufficient numbers of Security Guards (Males & Females); (b) Sufficient numbers of Door Metal Detectors; (c) 2 Frisking cabin for females; (d) 10 Nos of Walky Talky & 6 Handheld frisking devices.
- ix. Arrangement for uninterrupted power supply and payments to the electricity consumption will be the responsibility of the EMA.
- x. Comprehensive Insurance Cover for the event/ festival will be the responsibility of the EMA.

b) Addition of the new point number (F) in Scope of Work under Terms of Reference at Annexure-I.

- F. Event Management Agency is also required to make arrangements for artist performance, for musical evening, to take place on 28th Dec 2021 at open stadium in Varanasi which includes stage Design, LED on stage, sound, light to accommodate 10,000 people. [**Note: The payments to the EMA will be made only when the musical evening performance will be held in Open Stadium on 28th December 2021. In case, the proposed musical evening on Open Stadium could not be organised due to any reason, the payments will not be made to the agency**]

Specifications: -

- 1) Stage - 80x40x4 Feet
 - 2) Trussing - as per venue requirement
 - 3) Lighting
 - 4) Sound - RCF / Dash Audio / JBL Line Array
 - 5) Tech Rider - TBC
 - 6) LED screen on stage - as per stage requirement
 - 7) LED screens for audiences
3. Consequent to the above changes, bidders are requested to submit the financial proposal as per the revised financial proposal format (*Cover2_Annexure_III_Financial_Proposal_Revised.xlsx*).
4. **The proposals should be submitted by 1600 Hours on 17.12.2021** online on <https://becil.euniwizarde.com> and proposals will be opened on-line on same day at 1630 Hours. Bidders may be asked to make a presentation (on 18th December 2021) of their understanding of scope of work and their concept to implement and execute the Film Festival/ Musical Evening event.
5. All the other terms and conditions of the tender document No. BECIL/IPRD-UP/VFF/2021/Tender/01 shall remain unchanged.
