#### **ELILIGIBILITY CRITERIA AND EVALUATION**

#### 1. ELIGIBILITY CRITERIA OF BIDDERS

#### 1. Company/Bidder's Profile:

- (a) The Bidder shall be Company incorporated/registered in India under Companies Act 1956/2013/Proprietorship/Partnership firm/Limited Liability Partnership (LLP).
- (b) The bidder should have a valid PAN and GST Registration. Copy of PAN card and GST Registration certificate should be submitted in the bid.
- (c) The bidder should not be insolvent, in receivership, bankrupt or being wound up, not have had their business activities suspended and not be the subject of legal proceedings for any of the foregoing. An undertaking by the bidder should be submitted.
- (d) The Bidder should not be blacklisted/debarred/banned/restricted by any Union Govt. /State Govt. / PSU as on date of submission of the Bid. An undertaking by the bidder should be submitted.
- (e) The bidder holding the DEALER POSSESSION LICENSE (DPL) for supply of RF equipment is not eligible for this tender enquiry.

#### 2. **Financial Eligibility:**

- (a) The bidder must have minimum average annual turnover (of last three audited years) as Rs. 10 Lakh
  - Documentary evidence (in case of Company registered under the Indian Companies Act) in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be included with the response.
  - In case of Partnership firm/Proprietorship firm/Limited Liability Partnership (LLP) if the audited balance sheet is not applicable then certificate from the Chartered Accountant / Cost Accountant indicating the turnover details or ITR returns can also be submitted.
- (b) The bidder (in case of private Limited) should have positive net worth in each of last three audited Financial Years.

#### 2. PRELIMINARY EVALUATION

- 2.1 BECIL shall evaluate the proposals to determine that they are complete, technically complying, no computational errors have been made, required documents as mentioned in the EOI have been furnished, the documents have been properly signed and the response is generally in order. In case of any calculation error, the total (final) price shall be considered for evaluation.
- 2.2 BECIL may waive off any minor infirmity or non-conformity or irregularity in the proposal which does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of any OEM/Authorized Supplier/Agency/Partner.
- 2.3 In case only one bid is received or during the Technical Evaluation only one OEM/Authorized Supplier/Agency/Partner qualifies BECIL reserves the right to accept/reject the bid.

#### 3. EVALUATION PROCESS

- 3.1 No enquiry shall be made by the bidder/ Agency (s) during the course of evaluation of the EOI, after opening of bid, till final decision is conveyed to the successful OEM/Authorized/Supplier/Agency/Partner. However, the Evaluation Committee/its authorized representative and office of BECIL can make any enquiry/ seek clarification from the OEM/Authorized Supplier/Agency/Partner, which the OEM/Authorized Supplier/Agency/Partner must furnish within the stipulated time else the bids of such defaulting OEM/Authorized Supplier/Agency/Partner will be rejected. The proposal will be evaluated on the basis of its content, not its length.
- 3.2 OEM/Authorized Supplier/Agency/Partner proposals will be evaluated as per the requirements specified in the EOI and adopting the evaluation criteria spelt out in subsequent paras of this EOI document. The bidder/Agency are required to submit all required documentation as per evaluation criteria specified in EOI.
- 3.3 Upon verification, evaluation/ assessment, if in case any information furnished by OEM/Authorized Supplier/Agency/Partner is found to be Incomplete/incorrect, their bid will be summarily rejected and no correspondence on the same shall be entertained. Submission of false/forged documents will lead to blacklisting of agency for a minimum period of 3 years from participating in BECIL tenders.
- 3.4 BECIL will review the proposal to determine whether the proposals are as per the requirements laid down. Proposals that are not in accordance with these requirements are liable to be disqualified at BECIL's discretion.
- 3.5 Evaluation of proposals shall be based on:
  - 3.5.1 Information contained in the proposal, the documents submitted thereto and clarifications provided, if any.



- 3.5.2 Experience and Assessment of the capability of the OEM/Authorized Supplier/Agency/Partner based on past record.
- 3.6 BECIL reserves the right to seek any clarifications on the already submitted bid documents; however, no fresh documents shall be accepted in support of proposals.
- 3.7 Conditional proposals shall NOT be accepted on any ground and shall be rejected straightway. If any clarification is required by the bidders, the same should be obtained before submission of the proposals.
- 3.8 Even though OEM/Authorized Supplier/Agency/Partner satisfy the necessary requirements they are subject to disqualification if they have:
  - 3.8.1 Made untrue or false representation in the form, statements required in the EOI document.
  - 3.8.2 Records of poor performance such as abandoning work, not properly completing contract, financial failures or delayed completion.
