# Annexure- A

The following guidelines are currently being followed regarding the medical examination and vaccination for Main kitchen staff (Food Bearer and cook):

Medical Examination:

The following tests are conducted to ensure the health and hygiene standards of all food handlers:

- 1. Hemoglobin Percentage (HB%)
- 2. Liver Function Test (LFT)
- 3. Widal Test
- 4. Hepatitis A (Total Antibody Test)
- 5. Deworming
- 6. Stool Examination Routine/Microscopy (R/M)
- 7. Stool Culture and Sensitivity (C/S)- for detection of carrier state

Vaccination of Food Handlers:

The following vaccinations are advised for all food handlers working in the kitchen and cafeteria areas:

- 1. Hepatitis A Two doses at 0 months and 6 months
- 2. Hepatitis B-
  - If previously vaccinated, antibody titers are checked
  - · If required, a booster dose is administered
  - Standard schedule: 0 months, 1 month, and 6 months
- 3. Typhoid (Conjugate Vaccine)-
  - · Advised for all kitchen staff
  - One dose every 10 years
  - Booster doses may be recommended

These measures are implemented to maintain high standards of food safety and public health.

#### **Selection Process:**
