Monitors are required to check/scrutinize/examine the contents beamed by TV channels permitted for down linking within the Country on the basis of Programme and Advertisement code stipulations and identify apparent violations if any. Selection would be based on skill test-cum-interview to be held at Bengaluru while selected candidates would be engaged on contract basis through BECIL in EMMC in New Delhi.
